Registration Terms and conditions

1. Preamble:

These terms and conditions apply in conjunction with our General Terms and Conditions, which govern the use of the WLS 2026 website (URL), and shall be enforceable to the same extent.

WLA will hold the World Lottery Summit 2026 (WLS 2026) from 9-12 November 2026, in Sydney, Australia. By completing the form and proceeding with payment, you agree with the “Registration” Terms and Conditions without reserve.

2. Registration

The registration deadlines are as follows:

Registration period	Opening and closing dates
Online registration	27 May – 05 November at 23:59 CEST
Onsite registration	08 November from 10:00 CEST

Registration will only be confirmed upon receipt of full payment.

Registration is only available via the dedicated link provided on the WLS 2026 website. Any registration submitted through any other method will be automatically rejected.

3. Registration Fees

4. Individual registrations

All registrations are strictly personal and must be made in the name of the original registrant. A booking may also be made on behalf of the attendee by another person. In such cases, the registration is made under the sole responsibility of both the person making the booking and the person on whose behalf it is made. WLA shall not be held liable for any errors or incorrect registrations.

5 - Payment

All payments should be made in Australian Dollars (AUD or AUD\$) and should be processed through:

- 1. Bank Transfer:** Payments by bank transfer should be completed within ten (10) working days after registration. Registration will be confirmed when pending payment is received. Bank transfer will be accepted only until 23 October 2026. From 24 October 2026 credit card payments will be accepted. All bank charges must be borne by the ordering customer.
- 2. Credit card:** Online payment by credit card (VISA, Mastercard, American Express etc.). Online payment by credit card incurs a **surcharge of AUD 163.00**. This fee will be added to the total amount and will need to be paid by the participant/group leader. This fee is non-refundable.
- 3. Onsite:** Payment in cash is not possible onsite. The payment must be made by Credit Card.

A payment receipt/invoice will be sent to the attendee once the fully completed registration form and related payment is received. Invoices to an address in Australia should have an accompanying ABN Number.

The invoicing address and ABN number can only be set up during the registration process.

Any modification of the ABN number or billing address must be sent in writing to the WLS 2026 event organizer at wls@world-lotteries.org.

6. Registration modification

Modifications to registrations are not possible once the registration has been confirmed by clicking the button.

For any modification, attendees must contact the WLS 2026 event organizer at wls@world-lotteries.org to make changes to bookings.

7 - Registration confirmation

The registration confirmation together with the payment invoice will be sent to delegates upon completion of registration.

8 - Cancellation policy

Notification of cancellation must be made in writing and sent to the WLS 2026 event organizer at wls@world-lotteries.org. The notification must include the registration confirmation number, complete name, and the bank account or credit card to which a possible refund may be remitted.

a. Cancellation – Registration fees

Cancellations for registration notified before the end of business hours CEST (17:00 CEST) on 23 October 2026 will receive a full refund minus an administration charge of AUD 85.00 and bank or credit card charges.

Cancellations for registration received after the end of business hours CEST (17:00 CEST) on 23 October 2026, will not receive a refund.

b. Cancellation – City Tour

Cancellations for City Tour registration notified before the end of business hours CEST (17:00 CEST) on 15 October 2026 will receive a full refund minus an administration charge of AUD 60.00 and any bank or credit card charges.

Cancellations for City Tour registration received after the end of business hours CEST (17:00 CEST) on 23 October 2026, will not receive a refund.

WLA reserves the right to cancel the activity in the event that the number of participants is insufficient. In such a case, the full amount paid for the activity will be refunded to the participant. Please refer to the conditions of each activity on the registration form or on the website.

c. Cancellation – Opening dinner

Cancellations for Opening dinner registration notified before the end of business hours CEST (17:00 CEST) on 15 October 2026 will receive a full refund minus an administration charge of AUD 60.00 and any bank or credit card charges.

Cancellations for Opening dinner registration received after the end of business hours CEST (17:00 CEST) on 15 October 2026, will not receive a refund.

d. Cancellation – Closing dinner

Cancellations for Closing dinner registration notified before the end of business hours CEST (17:00 CEST) on 15 October 2026 will receive a full refund minus an administration charge of AUD 60.00 and any bank or credit card charges.

Cancellations for Closing dinner registration received after the end of business hours CEST (17:00 CEST) on 15 October 2026, will not receive a refund.

e. Cancellation – Networking Day

Cancellations for Networking Day registration notified before the end of business hours CEST (17:00 CEST) on 15 October 2026 will receive a full refund minus an administration charge of AUD 60.00 and any bank or credit card charges.

Cancellations for Networking Day registration received after the end of business hours CEST (17:00 CEST) on 15 October 2026, will not receive a refund.

WLA reserves the right to cancel the activity in the event that the number of participants is insufficient. In such a case, the full amount paid for the activity will be refunded to the participant. Please refer to the conditions of each activity on the registration form or on the website.

9 - Letter of invitation

Individuals requiring an official letter of invitation can request one directly from the WLS 2026 event organizer via the registration form.

To receive the letter of invitation, attendees must first register for the event, fill in the dedicated section on the registration form and submit the full payment.

When payment is received, a signed invitation letter will be forwarded to the attendee. Any and all expenses incurred in relation to event attendance are the sole responsibility of the attendee.

10 - Eligibility

The minimum age for participants is 18 years old. Persons under the age of 18 will not be allowed access to any parts of the conference.

It is the participants' sole responsibility to ensure that the above-mentioned age of majority aligns with the laws of their country.

11. Data protection and sharing of contact details

a. Data provided during the booking process (contact and payment details)

All data provided during the booking process may be used (saved, stored, processed, transmitted, shared and deleted, but not modified) to allow the processing and execution of the participant's booking(s). The legal basis is the performance of a contract, or the steps taken at the request of the data subject prior to entering into a contract (art. 6 § 1 lit. b GDPR).

All data provided will be stored for the period of time necessary for the processing and the execution of the participant's booking. After the WLS 2026, they will be archived for 10 years for legal purposes.

The WLA may also use data provided to send the participant information regarding congress or seminar activities as well as other communications related to congress or seminar activities that may be of interest. The participant can unsubscribe to the communications at any time by clicking the "unsubscribe" link at the bottom of each communication.

b. Data recorded during the conference

With consent of the participants, the WLA may use photos and recordings for promotional purposes. The participants agree that any images in which they may appear may be used in relation to the promotion of the World Lottery Summit 2026, of the future WLA events and on WLA websites. 12 - Code of conduct

The WLA is committed to providing a professional, friendly, and safe environment for all participants regardless of gender, sexual orientation, disability, race, ethnicity, religion, national origin, or other protected class. All participants (including delegates, staff, speakers, exhibitors, and other guests) agree, by registering, to abide by the behavior rules detailed in

The WLA reserves the right to take action if this code of conduct is breached.

13 - Limitation of Liability

TO THE FULLEST EXTENT PERMITTED BY LAW, WLA'S TOTAL LIABILITY ARISING OUT OF OR RELATED TO THESE REGISTRATION TERMS AND CONDITIONS SHALL NOT EXCEED THE TOTAL FEES PAID BY THE PARTICIPANT FOR THE RELEVANT SERVICE. IN NO EVENT SHALL WLA BE LIABLE FOR ANY INDIRECT, INCIDENTAL, SPECIAL, OR CONSEQUENTIAL DAMAGES.

14 – Applicable Law and jurisdiction

These Registration Terms and Conditions shall be governed by and construed in accordance with the substantive laws of Switzerland, without regard to its conflict of laws principles.

Any dispute, controversy, claim, or difference arising out of or in connection with these Registration Terms and Conditions shall be submitted to the exclusive jurisdiction of the competent courts in Lausanne, Switzerland. The Parties hereby irrevocably submit to the personal jurisdiction of these courts.
