## Trade Show Registration Terms and conditions

### 1. Preamble:

---

These terms and conditions apply in conjunction with our General Terms and Conditions, which govern the use of the WLS 2026 website (worldlotterysummit.org), and shall be enforceable to the same extent.

WLA will hold the World Lottery Summit 2026 (WLS 2026) from 9-12 November 2026, in Sydney, Australia. By completing the form and proceeding with payment, you agree with the "Trade Show Registration" Terms and Conditions without reserve.

### 2. Registration

---

The registration deadlines are as follows:

- **Opening date:** May 27, 2026
- **Closing date:** August 16, 2026

Registration will only be confirmed upon receipt of full payment.

**Registration is only available via the dedicated link provided on the WLS 2026 website. Any registration submitted through any other method will be automatically rejected.**

### 3. Registration Fees

---

#### a. Categories of registration fees

The registration fees are divided into 4 (four) categories:

- WLA Platinum Contributor
- WLA Gold Contributor
- WLA Associate Member
- WLA Non Associate Member

For the avoidance of doubt, the terms "Platinum Contributor", "Gold Contributor" and "Associate Member" refer to the definition set out in the WLA by-laws.

#### 4. Booth registrations

---

Registration is made under the sole responsibility of the company, including all information provided and options selected. WLA shall not be held liable for any errors or incorrect registrations.

#### **These provisions apply to all companies / exhibitors except Platinum and Gold Contributors:**

Each registration must include three preferred booth number choices, as well as the desired number of square meters.

Any registration that does not specify the number of square meters will not be processed and will be automatically cancelled.

Final booth allocation will be determined based on the time of receipt of a complete registration. The company that first submits a complete registration form (with no missing information) will be assigned its first-choice booth. If that booth has already been allocated, the company will be assigned its second choice, and if that is also unavailable, its third choice.

#### 5 - Payment

---

All payments should be made in Australian Dollars (AUD or AUD\$) and should be processed through **Bank Transfer**. Payments by bank transfer should be completed within ten (10) working days after registration. Registration will be confirmed when pending payment is received. Bank transfer will be accepted only until 31 August 2026.

All bank charges must be borne by the ordering customer.

A payment receipt/invoice will be sent to the company once the fully completed registration form and related payment is received. Invoices to an address in Australia should have an accompanying ABN Number.

The invoicing address and ABN number can only be set up during the registration process.

**IF FULL PAYMENT HAS NOT BEEN RECEIVED IN DUE TIME IN ACCORDANCE WITH THIS SECTION, THE EXHIBIT BOOTH SPACE WILL BE RELEASED AFTER THE 10TH DAY.** WLA reserves the right to charge the exhibitor an administration fee of AUD 85.00.

### 6. Registration modification

---

Modifications to registrations are not possible once the registration has been confirmed by clicking the button.

For any modification, company must contact the WLS 2026 event organizer at [wlsbooth@world-lotteries.org](mailto:wlsbooth@world-lotteries.org) to make changes to bookings.

### 7 - Registration confirmation

---

The registration confirmation will be sent to the contact person upon completion of the registration.

The registration confirmation will include the assigned booth number, as well as the **Exhibitor Manual**, which provides all necessary information, including **technical details and booth specifications**.

A second email including the **invoice** will be sent to proceed with the payment.

### 8 - Cancellation policy

---

Notification of cancellation must be made in writing and sent to the WLS 2026 event organizer at [wlsbooth@world-lotteries.org](mailto:wlsbooth@world-lotteries.org). The notification must include the registration confirmation number, complete name, and the bank account to which a possible refund may be remitted.

Cancellations for Trade show registration notified before the end of business hours CEST (17:00 CEST) on August 16, 2026 will receive a 50% refund of the amount paid.

Cancellations for Trade show registrations notified after the end of business hours CEST (17:00 CEST) on August 16, 2026 will not receive a refund.

### 9. Data protection and sharing of contact details

#### a. Data provided during the booking process (contact and payment details)

All data provided during the booking process may be used (saved, stored, processed, transmitted, shared and deleted, but not modified) to allow the processing and execution of the participant's booking(s). The legal basis is the performance of a contract, or the steps taken at the request of the data subject prior to entering into a contract (art. 6 § 1 lit. b GDPR).

All data provided will be stored for the period of time necessary for the processing and the execution of the participant's booking. After the WLS 2026, they will be archived for 10 years for legal purposes.

The WLA may also use data provided to send the participant information regarding congress or seminar activities as well as other communications related to congress or seminar activities that may be of interest. The participant can unsubscribe to the communications at any time by clicking the "unsubscribe" link at the bottom of each communication.

#### b. Data recorded during the conference

With consent of the participants, the WLA may use photos and recordings for promotional purposes. The participants agree that any images in which they may appear may be used in relation to the promotion of the World Lottery Summit 2026, of the future WLA events and on WLA websites. These Registration Terms and Conditions shall be governed by and construed in accordance with the substantive laws of Switzerland, without regard to its conflict of laws principles.

Any dispute, controversy, claim, or difference arising out of or in connection with these Registration Terms and Conditions shall be submitted to the exclusive jurisdiction of the competent courts in Lausanne, Switzerland. The Parties hereby irrevocably submit to the personal jurisdiction of these courts.
